Purpose:

To develop and/or improve province wide tools to enhance
The use of the conservation easement tool on private land

Objectives:

- Identify actions to enhance the delivery of CE's
- Identify improvements to the CE tool and enhance delivery
- Identify other tools that would support or enhance delivery conservation on private land

Land Trust Leadership Project Overview

Recommendations included a need for:

- A coordinated and networked provincial alliance
- A conference/workshop
- Capacity building for land trusts
- Education (awareness campaign for landowners, professionals and municipalities)

- Land securement assistance program
- Links to the GOA (eg. Land Use Framework)
